Hutton Cranswick Parish Council

Minutes of the Meeting of the Parish Council, held on the 17th May, 2023. The meeting was held at the WI Hall, Main Street, Cranswick and commenced at 7.42 pm.

Present: Councillors: Alderton, Holtby (left after item 11- minute 23/140), Ingham, Jones, Richardson, Sibley-Calder, Swan, Teare, Thompson (in the Chair). Parishioners: 2. The Clerk recorded the minutes.

23/131 Apologies: Councillors: Kelly, Mrs Simpson. Ward Councillor: Dewhirst.

23/132 Declaration of Pecuniary and Non-Pecuniary Interests: -

Cllr Ingham - Item 10(a) Minute 23/239(a) - Non-pecuniary - In-Bloom Member.

23/133 Membership of the Council – Resolved to Co-opt Rich Bucknall and John Poolford onto the Council. The two new councillors signed a Declaration of Acceptance of Office and were invited to join the meeting by the Chairman. The Council now had full Membership of 13 Councillors.

23/134 Financial Monitoring: -

- (a) 2023-24 Budget Month 2 position included receipts: £18,525.50 Precept and £8,151.68 farming allotment rents.
- (b) The Bank Reconciliation at May, 2023 was £119,227.36.
- 23/135 The Public Sector Deposit Fund (PSDF) –The PSDF was operated by Churches, Charities and Local Authorities (CCLA) Investment Management Limited. The Fund was a cash based, AAA rated, money market fund, with daily dealing and easy access to cash. The fund was low risk, provided good liquidity and good yield. There were over 800 Local Authority clients and around 500 Town and Parish Councils who invested with CCLA. CCLA works closely with The East Riding and Northern Lincolnshire Local Councils Association and National Association of Local Councils Resolved that the Clerk looks into the benefits for the Council in opening a PSDF Account (proposed Cllr Teare/seconded Cllr Richardson).
- 23/136 Request from the Friends of Hutton Cranswick CP School Deferred.
- 23/137 Planning Matters The following decision was noted:
- (a) 23/00049/STVAR: Variation of Condition 6 (planting) and Condition 11 (approved plans) of planning application 22/01822/STVAR Variation of Condition 6 (hedgerows), Condition 9 (foul and surface water drainage) and Condition 11 (approved plans) of planning permission 21/03060/STVAR (Variation of Condition 10) (approved plans of planning permission 19/04321/STPLF Construction of a solar farm and battery storage facility, together with all associated works, equipment and necessary infrastructure) at Land North East of Eastfield Farm, Stockbridge Lane, Hutton Cranswick, East Riding of Yorkshire, YO25 9RB Strategic Variation of Conditions Permission Granted -10 Conditions.
- 23/138 Planning Applications Resolved That each application received with a deadline for comments before the 28th June, 2023 or an application received after 21st July, 2023 with the deadline for comments before the 27th September, 2023, then the application was to be considered via e-mail (hard copy). If there was no objection to the application, the Council's comment was to be recorded as 'No Objection'. If an objection was raised on the application, then an extra-ordinary meeting was to be arranged to make a decision on the application, unless a consensus was reached as to the grounds for the objection. Decisions on all applications, as above, would be recorded at the pext available parish council meeting (proposed Cllr Sibley-Calder/seconded Cllr Alderton).

23/139 Representatives reports: -

(a) In Bloom – Driffield & Wolds Weekly had published details of the Hutton Cranswick Yorkshire in Bloom entry. The date for judging was still to be confirmed. Students from Hymers College were to carry out work at the Station on the 27th June, 2023. A workplan for the students was still to be finalised.

The new Hutton Cranswick in Bloom plaques, funded by the Ancient Order of Foresters, were all in place.

The first of a series of visits to the SRA, by students from Kings Mill School, commenced on the 4th May, 2023. This programme provided work experience for the students. The work would include re-paint/stain some of the outside tables and benches and generally tidying the car park and planted area.

Work on planting up the area below the direction sign at the junction of Megginson's Turnpike and Station Road was on hold, pending East Riding of Yorkshire Council to make good the damaged signpost.

(b) SRA – Over 700 people had attended The Coronation Party. Both the archery and tennis groups had recruited new members following the "have a go" sessions. The Committee was considering holding a Cranswick Fun Day at the end of May in 2024. Feedback on what the 'new build' should cater for asked for more of a focus on sports and leisure activities, a youth club and family fun days. As a result of these responses, the Committee considered the 'new build' was better described as being a community hall.

Concern was expressed about the increase in traffic. One suggestion, that should the plans go ahead for building the proposed new houses off Hobman Lane, the developer should be asked to include a village hall in the plans.

Refurbishment and remodelling of the kitchen was planned to start in June. An appointment of an assistant grounds-person was imminent.

- (c) Pond Cllr Sibley-Calder continued to monitor the state of the pond.
- (d) Village Show 22nd July, 2023 The Committee was recruiting volunteers for the Show.
- 23/140 New Year Honours Cabinet Office guidance on individuals and Volunteer Groups was noted.
- 23/141 Hutton Road The damage to the highway verge was to be inspected by East Riding of Yorkshire Council.
- 23/142 Play Area The Council's continued aim to remove high and medium risks had been achieved, as the annual inspection of the play park identified only a number of minor repairs classed as low or very low risk. Appropriate action was to be taken. Two quotations for a replacement cantilever basket swing were both in excess of £10, 000.00. It was **Resolved** to make good the existing swing (proposed Cllr Alderton/seconded Cllr Swan).
- 23/143 Parking near St Peter's Church East Riding of Yorkshire Council's Property and Commercial Law Manager was to confirm the legal status of the areas proposed for car parking.
- 23/144 Community Speed Watch Group Eight residents and three Councillors had expressed an interest in joining the Group. Cllr Holtby was nominated to progress establishing a Village Community Speed Watch Group.
- 23/145 Garden and Farming allotments Resolved to appoint Cllr Poolford to the Garden Allotment and Farming Allotment working groups (proposed Cllr Teare/seconded Cllr Sibley-Calder). Some allotments needed attention. Cllrs Swan and Poolford were to carry out an inspection of the allotments and request the Clerk to remind

tenants to take action where appropriate. As there were now six vacant allotments, it was **Resolved** to allow allotments to be let to residents in neighbouring villages (proposed Cllr Poolford/seconded Cllr Sibley-Calder).

Cllr Ingham requested that the Clerk seek clarification as to whether eggs from chickens reared on the allotments were being sold.
